Impeaching Donald John Trump, President of the United States for high crimes and misdemeanors.

Mr. AL GREEN of Texas submitted the following resolution;

RESOLUTION

Impeaching Donald John Trump, President of the United States, for high crimes and misdemeanors.

- 1 Resolved, That Donald John Trump, President of the United
- 2 States, is an abuser of presidential power who, if left in office,
- 3 will continue to promote the incitement of violence, engender
- 4 invidious hate, undermine our democracy, and dissolve our
- 5 Republic, that he is impeached for high crimes and mis-

- 1 demeanors, and that the following articles of impeachment be 2 exhibited to the United States Senate:
- Articles of impeachment exhibited by the House of 4 Representatives of the United States of America in the name of 5 itself and of the people of the United States of America, ag-6 ainst Donald J. Trump, President of the United States of 7 America, in maintenance and support of its impeachment 8 against him for high crimes and misdemeanors.

9 ARTICLE I

10 Abuse of Presidential Power by Calling for the Execution

- of Members of Congress
- In his conduct of the office of President of the United States, 13 Donald John Trump, in violation of his constitutional oath to 14 faithfully execute the office of the President of the United 15 States and, to the best of his ability, preserve, protect, and def-16 end the Constitution of the United States, and in violation of 17 his constitutional duty to take care that the laws be faithfully 18 executed, has unfaithfully, dangerously, and unconstitutionally 19 abused his official position by threatening Democratic law-20 makers in Congress with execution.
- President Trump called for the execution of six Democratic 22 lawmakers, all of whom are currently serving in the U.S. Senate 23 or U.S. House of Representatives and who previously served in 24 the U.S. Military or in U.S. Intelligence communities, in respo-

1 nse to a short video that they posted on November 18, 2025.¹
2 In their video, the Democratic lawmakers appropriately urged
3 current members of the military and intelligence communities
4 to adhere to the Constitution and the laws of our country. They
5 specifically said: "Like us, you all swore an oath to protect and
6 defend this Constitution. Right now, the threats to our
7 Constitution aren't just coming from abroad, but from right here
8 at home. Our laws are clear. You can refuse illegal orders. You
9 can refuse illegal orders. You must refuse illegal orders. No one
10 has to carry out orders that violate the law or our
11 Constitution."

On November 20, 2025, in response, President Trump call13 ed for their execution. In one social media post, he wrote: "It's
14 called SEDITIOUS BEHAVIOR AT THE HIGHEST LEVEL.
15 Each one of these traitors to our Country should be ARREST16 ED AND PUT ON TRIAL. Their words cannot be allowed to
17 stand – We won't have a Country anymore!!! An example
18 MUST BE SET. President DJT." In another, he wrote of the
19 lawmakers: "SEDITIOUS BEHAVIOR, punishable by
20 DEATH!" Dangerously and unconstitutionally, he reposted a
21 third party's post: "HANG THEM GEORGE WASHINGTON
22 WOULD!!"

President Trump's call for the execution of lawmakers is a 2 reckless and flagrant abuse of presidential power that promo-3 tes extra-judicial punishment and the assassination of Members 4 of Congress, and warrants impeachment by the U.S. House of 5 Representatives and trial by the Senate.

6 ARTICLE II

7 Abuse of Presidential Power to Intimidate Federal Judges 8 in Violation of the Separation of Powers and Independence 9 of the Judiciary

- In his conduct of the office of President of the United 11 States, Donald John Trump, in violation of his constitutional 12 oath to faithfully execute the office of President of the United 13 States and, to the best of his ability, preserve, protect, and de-14 fend the Constitution of the United States, and in violation of 15 his constitutional duty to take care that the laws be faithfully 16 executed, has unfaithfully, dangerously, and unconstitutionally 17 abused his official position by threatening federal judges.
- President Trump has fostered a political climate in which lawmakers and judges face threats of political violence and 20 physical assault; and in this climate has made threats and vituperative comments against federal judges, putting at risk their 22 safety and well-being, and undermining the independence of 23 our judiciary.
- Case in point, in response to a federal district court ruling with which President Trump disagreed, he posted: "This Radical Left Lunatic of a Judge, a troublemaker and agitator who was sadly appointed by Barack Hussein Obama, was not

1 elected President...This judge, like many of the Crooked 2 Judges' I am forced to appear before, should be 3 IMPEACHED!!!"5

- Another U.S. District Chief Judge has reported receiving in-5 creased numbers of violent threats, particularly after he began 6 hearing arguments in a lawsuit against the Trump adm-7 inistration.⁶
- In 2025, roughly a third⁷ of the federal judiciary has been 9 flooded with threats, with data showing that these threats 10 spike⁸ each time Trump uses abusive rhetoric against judges.
- On May 2, 2025, Reuters reported that U.S. Supreme Court 12 Justice Ketanji Brown Jackson addressed President Donald 13 Trump's attacks on the judiciary. The relevant part of the article 14 stated as follows:⁹
- 15 1) "U.S. Supreme Court Justice Ketanji Brown Jackson
- said on Thursday attacks by Republican President
- 17 Donald Trump and his allies on judges were 'not ran-
- dom' and seemed 'designed to intimidate the judic-
- 19 *iary.* '"

- 1 2) Specifically, U.S. Supreme Court Justice Jackson rem-
- 2 arked that, "The attacks are not random. They seem des-
- 3 igned to intimidate those of us who serve in this critical
- 4 capacity."
- 5 3) Justice Jackson added, "The threats and harassment are
- 6 attacks on our democracy, on our system of government.
- 7 And they ultimately risk undermining our Constitution
- 8 and the rule of law."
- The judiciary is afforded power over "all Cases, in Law 10 and Equity, arising under this Constitution, the Laws of the 11 United States, and Treaties made" and "to Controversies to 12 which the United States shall be a Party." U.S. Const. art. III, 13 sec. 2. Intimidating judges, and recklessly calling for the imp-14 eachment and removal of judges who disagree with him dem-15 onstrate a willingness by Trump to usurp authority afforded by 16 our Constitution to the judiciary and demonstrate a disregard 17 for the Constitution and the careful balance of powers that pro-18 tects our country from abuses by any single branch.
- President Trump's threats place the lives of federal judges, 20 court officials, and innocent bystanders at risk, promote the 21 incitement of violence, and undermine our democracy, which 22 cannot survive where President Trump's incendiary comments 23 engender invidious hate and where dissent is punishable by 24 death.
- In all of this, Donald John Trump has acted in a manner 26 contrary to his trust as President and subversive of constitut-27 ional government to the great prejudice of the cause of law

- 1 and justice and to the manifest injury of the people of the 2 United States.
- Wherefore Donald John Trump, by such conduct, warrants 4 impeachment, trial, and removal from office.
