I am requesting funding for the Multi-Use Park – E.P.Hill in fiscal year 2024. The entity to receive funding for this project is City of Houston, located at 611 Walker Street, Houston TX 77002. The funding would be used to construct a 5 acre-feet of recreational detention for the Sunnyside neighborhood. The creation of multi-use detention will benefit future drainage improvements to the Sunnyside storm sewer system. The project is an appropriate use of taxpayer funds because the detention in the park would provide flood benefits by capturing storm overflows from the neighborhood to the north

The project has a Federal nexus because the funding provided is for purposes authorized by 42 U.S.C. 5305(a)(1) and 42 U.S.C. 5305(a)(2).
