I am requesting funding for Pro-Vision Villages at Chocolate Bayou in fiscal year 2024. The entity to receive funding for this project is Pro-Vision, Inc., located at 4302 Reed Road, Houston, Texas 77051. The funding would be used for the development for the Sunnyside Community that will be comprised of senior living, multi-family and single-story housing. The development proposes a total of 243 family units, 185 senior units, and 34 cottages.
