**A BILL**

For the relief of Jaime Avalos Rosales.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PERMANENT RESIDENT STATUS FOR JAIME**  
4       **AVALOS ROSALES.**

5       (a) IN GENERAL.—Notwithstanding subsection (a)  
6       and (b) of section 201 of the Immigration and Nationality  
7       Act, Jaime Avalos Rosales shall be eligible for issuance  
8       of an immigrant visa or for adjustment of status to that  
9       of an alien lawfully admitted for permanent residence  
10      upon filing an application for issuance of an immigrant

1 visa under section 204 of such Act or for adjustment of  
2 status to lawful permanent resident.

3 (b) ADJUSTMENT OF STATUS.—If Jaime Avalos  
4 Rosales enters the United States before the filing deadline  
5 specified in subsection (d), he shall be considered to have  
6 entered and remained lawfully and shall, if otherwise eligi-  
7 ble, be eligible for adjustment of status under section 245  
8 of the Immigration and Nationality Act as of the date of  
9 the enactment of this Act.

10 (c) WAIVER OF GROUNDS FOR REMOVAL OR DENIAL  
11 OF ADMISSION.—

12 (1) IN GENERAL.—Notwithstanding sections  
13 212(a) and 237(a) of the Immigration and Nation-  
14 ality Act, Jaime Avalos Rosales may not be removed  
15 from the United States by reason of any ground for  
16 removal or denial of admission that is reflected in  
17 the records of the Department of Homeland Security  
18 or the Visa Office of the Department of State on the  
19 date of the enactment of this Act.

20 (2) RESCISSION OF OUTSTANDING ORDER OF  
21 REMOVAL.—The Secretary of Homeland Security  
22 shall rescind any outstanding order of removal or de-  
23 portation, or any finding of inadmissibility or de-  
24 portability, that has been entered against Jaime

1       Avalos Rosales by reason of any ground described in  
2       paragraph (1).

3       (d) DEADLINE FOR APPLICATION AND PAYMENT OF  
4 FEES.—Subsections (a) and (b) shall apply only if the ap-  
5 plication for issuance of an immigrant visa or the applica-  
6 tion for adjustment of status is filed with appropriate fees  
7 within 2 years after the date of the enactment of this Act.

8       (e) REDUCTION OF IMMIGRANT VISA NUMBER.—  
9 Upon the granting of an immigrant visa or permanent res-  
10 idence to Jaime Avalos Rosales, the Secretary of State  
11 shall instruct the proper officer to reduce by 1, during the  
12 current or next following fiscal year, the total number of  
13 immigrant visas that are made available to natives of the  
14 country of the alien's birth under section 203(a) of the  
15 Immigration and Nationality Act or, if applicable, the  
16 total number of immigrant visas that are made available  
17 to natives of the country of the alien's birth under section  
18 202(e) of such Act.

19       (f) DENIAL OF PREFERENTIAL IMMIGRATION TREAT-  
20 MENT FOR CERTAIN RELATIVES.—The natural parents,  
21 brothers, and sisters of Jaime Avalos Rosales shall not,  
22 by virtue of such relationship, be according any right,  
23 privilege, or status under the Immigration and Nationality  
24 Act.
